- A utility bill credit is available to encourage GP&L **Residential Customers** to install high-efficient window air conditioning units with an Energy Star Rating. No credits will be issued for applications received after September 30, 2025.** Program ends September 30th, 2025 or when funds are depleted, whichever comes first. Program may be discontinued or modified by GP&L at any time. Please call 972-205-2929 to make sure the program is still available before purchasing equipment.
- Applications are subject to verification. If the verification cannot be completed, the credit will not be issued.
- The unit must be placed in service in the GP&L service area. **Existing homes only.**
- The credit recipient must be a GP&L customer. Please allow 2 to 8 weeks after receipt of all documentation for the credit to be posted to your GP&L account.

The window unit A/C must be **ENERGY STAR®** rated. **(Limit (3 units) per year, per account)**

- Room Air Conditioners 8,000 Btu/hr. or smaller \$250/unit
- Room Air Conditioners greater than 8,000 Btu/hr. \$300/unit
